Dear Chairman Goldner:

On July 29, 2024, the New Hampshire Public Utilities Commission ("Commission") approved the assented-to request to amend the procedural schedule previously filed by Pennichuck Water Works, Inc., Pennichuck East Utility, Inc., Pittsfield Aqueduct Company (collectively "Joint Petitioners") filed on February 28, 2024 that was approved on March 4, 2024. On September 12, 2024, the Department of Energy ("Department") filed a recommendation that the parties pursue the settlement track for the current schedule approved on March 4, 2024, as amended on July 29, 2024. In light of ongoing settlement discussions between the parties, the Joint Petitioners request to amend the procedural schedule to provide additional time for filing supplemental testimony, discovery and negotiations. The Joint Petitioners, with the assent of the Department, Office of Consumer Advocate ("OCA"), and intervenors, City of Nashua, Town of Bedford, Town of Londonderry and Town of Litchfield, request the following changes to the approved procedural schedule:

This schedule proposes to amend the settlement filing date to December 3, 2024, and hearing on the merits for the settlement on December 17, 18, or 19th. There will be no undue hardship placed on the Joint Petitioners or parties if the amended schedule is approved.
