Joint Petition to Approve Transfer of Control


Procedural Order Re: Adequacy of Notice

On August 9, 2024, the Commission issued Order No. 27,045, which required Consolidated Communications Holdings, Inc. (CCHI) and Condor Holdings LLC (Condor) to publish it “on their websites, as well as [Consolidated Communications of Northern New England Company, LLC’s] (CCNE) and [Consolidated Communications of Maine Company’s] (CCM) websites, no later than five business days after the date of issue, such publication to be documented by affidavit filed with the Commission on or before August 19, 2024.” On August 15, 2024, CCHI filed a letter notifying the Commission that it had published a copy of Order No. 27,045 on its website. CCHI previously stated in its February 28, 2024 affidavit that it had published the February 16, 2024 order of notice on its website, but that it did not maintain separate websites for its subsidiaries, such as CCNE and CCM. Condor filed a letter on August 19, 2024 confirming that it has no website.


Although not in affidavit form, CCHI’s August 15 letter indicates that Order No. 27,045 was published on its website.¹ This is the same form of notice used for publishing the February 16 order of notice, which the Commission deemed sufficient. Therefore, the Commission finds that CCHI and Condor have satisfied the notice requirement of Order No. 27,045.

¹ The notice on CCHI’s website, however, incorrectly lists the docket number as “DT 23-303.”
