**Joint Petition to Approve Transfer of Control**

**Procedural Order Re: Intervention Requests and Proposed Procedural Schedule**

The Commission issued an order of notice in this docket on February 16, 2024, which scheduled a prehearing conference and technical session on March 27, 2024 and set deadlines for filing petitions to intervene (March 8, 2024), objections to petitions to intervene (March 18, 2024), and a stipulation regarding a discovery schedule (March 20, 2024). Timely petitions to intervene were filed by the following: Charter Fiberlink NH-CCO, LLC (Charter Fiberlink) and Time Warner Cable Information Services (New Hampshire), LLC (Time Warner); the International Brotherhood of Electrical Workers, AFL-CIO (IBEW), Second District, and IBEW, Local 2320; the Town of Benton; the Town of Greenfield; and the New Hampshire Electric Cooperative, Inc. No objections to any of the petitions to intervene were filed.


The Commission finds that the intervention of these parties would be in the interests of justice and would not impair the orderly and prompt conduct of this proceeding. Accordingly, it GRANTS the foregoing petitions to intervene pursuant to RSA 541-A:32, II. The Commission reserves the right to modify this order, if necessary. *See id.*, V.


On March 20, 2024, Consolidated Communications Holdings, Inc. (CCHI) filed a proposed procedural schedule, with a request to cancel the March 27 prehearing conference and technical session. CCHI represented that the petitioners and all other parties to this proceeding assented to the proposed procedural schedule and request to cancel.


The Commission APPROVES the proposed assented-to procedural schedule and CANCELS the March 27, 2024 prehearing conference and technical session. Since the March 27 prehearing conference has been canceled, the unassented-to request for remote participation filed on March 12, 2024 on behalf of Charter Fiberlink and Time Warner is now moot.

Full day hearings in this matter have been scheduled on July 23 and July 24, 2024, starting each day at 9:00 a.m. These hearings will be conducted in person, in accordance with the previously issued hearing guidelines.
