On behalf of Pennichuck East Utility, Inc., (“PEU” or “Company”) please find the attached, Revised Motion to Amend the Petition filed in Docket No. DW 24-06 for your review and consideration. In response to the Commission’s Procedural Order on July 8, 2024, PEU respectfully submits this Revised Motion to Amend the Petition including the revised Petition, revised Direct Testimony of George Torres, revised Exhibit GT 1-4 (PDF and live Excel), revised Exhibit GT-9, and new Exhibits GT-10 and GT-11. The revised portions of the petition, direct testimony and exhibits are marked “Amended” where there were edits made to the filed documents.

This revised motion to amend the petition will adjust the relief sought for the total loan amount (\$1,890,931), correct testimony and exhibits regarding the relief sought and dates that approvals were sought and granted from the City of Nashua, as well as supplemental information regarding the consent from T.D.
