Request for Change in Distribution Rates

Petition of Aleksandar Milosavljevic-Cook for Intervention

Pursuant to the Order of Notice issued by the New Hampshire Public Utilities Commission on May 3, 2024 in the above-captioned proceeding, N.H. Code Admin. Rules Puc 203.17, and RSA 541-A:32, Aleksandar Milosavljevic-Cook hereby petitions for leave to intervene in this matter. In support of its petition I, Aleksandar Milosavljevic-Cook, state as follows:

Rule PUC 203.17 provides that the Commission shall grant petitions to intervene in accordance with the standards of RSA 541-A:32. RSA 541-A:32, part of the Administrative Procedure Act, provides that a petition to intervene shall be granted upon a showing that the petitioner has “rights, duties, privileges, immunities or other substantial interests” that may be affected by the proceeding, and “the interests of justice and the orderly and prompt conduct of the proceedings would not be impaired by allowing the intervention.”

DE 24-070 intends to review and determination distribution rates for Eversource Energy. For the reasons that follow, these determinations may impact the rights, duties, privileges, immunities, or other substantial interests of Aleksandar Milosavljevic-Cook.

I, Aleksandar Milosavljevic-Cook, residing in Sanbornville, New Hampshire and with a mailing address of PO Box 102, Sanbornville, NH 03872, am a customer of Eversource Energy, a

corporation which is regulated by the New Hampshire Public Utilities Commission. As such, I am subject to electricity rates charged by Eversource Energy which are determined and regulated by the New Hampshire Public Utilities Commission

I, Aleksandar Milosavljevic-Cook, have more than fifteen years of experience in the energy industry, having played an direct role in the greenfield development and/or upgrade of energy-related infrastructure throughout the United States and Canada, numerous assets of which are owned and/or operated by regulated utilities. During this time period I have become familiar with utility rates and rate setting practices and procedures. In my opinion, vertain Eversource Energy electricity rates are antiquated and wholly ineffective and can be vastly improved upon to 1) ameliorate choices for electricity customers in the State of New Hampshire and, 2) create consequential beneficial impacts upon electricity infrastructure in the State of New Hampshire and neighboring New England states.

WHEREFORE, Aleksandar Milosavljevic-Cook respectfully request that this honorable Commission:

- A. Grant the petition for intervention, and
- B. Provide any other such relief as it deems appropriate.
