**Procedural Order Re: AARP Motion to Reconsider and Request for Remote Participation**


On September 30, 2024, the Commission DENIED AARP New Hampshire's (AARP) Motion for remote participation at the October 2, 3, 8, and 9, 2024 prehearing technical sessions in this matter. The denial was based on AARP's untimely filing of its motion and failure to provide an explanation as to why AARP could not appear in person. On October 1, 2024, AARP filed a motion requesting the Commission reconsider its decision regarding the remote appearance of its representative John B. Coffman. AARP indicated that Mr. Coffman resides in Missouri and traveling to New Hampshire would be costly. Furthermore, AARP, noting that it was a late intervenor in this matter, explained that the request for remote participation was made as soon as they were made aware of the proceedings.

Based on the additional information provided the Commission hereby GRANTS AARP's request that its representative John B. Coffman be permitted to participate remotely during the October 2, 3, 8, and 9, 2024 technical session scheduled in the above-captioned docket. Given the short amount of time remaining before the October 2, 2024 technical session, the Commission waives New Hampshire Code of Administrative Rules, Puc 203.07(e). The filing of a separate request will be required for any other parties or witnesses wishing to appear remotely.
