All pages listed above, except pages Fourteenth Revised Page 5-A and Second Revised Page 69-D and 69-G, were filed with UES's initial and revised rate filing. Changes to Pages 69-D and 69-G are the result of a date change, per the Commission's Order. Fourteenth Revised Page 5-A for effect December 1, 2024 has been filed to reflect the application of approved ratios to approved rates. As part of its initial filing in this docket, UES stated that it would file a revised version of Page 5-A for effect December 1, 2024 "in compliance with a Commission order in this docket once it receives approval of all currently requested August 1, 2024 rate changes. If the proposed August 1, 2024 rates are approved as filed, the time varying rates that would be included on tariff Page 5-A, for effect December 1, 2024, are the ones shown on Schedule LSM-3". UES August 1, 2024 rates were approved as filed. For ease of review, Schedule LSM-3, marked as part of Exhibit 2, has been provided as part of this submission.
