Pursuant to Puc 2204.04 I am writing to provide official Notification of Community Power Aggregation Commencement of Service not sooner than 45 days hence, or on or after October 1, 2024, with the target month for enrollments being October 2024 for the following municipalities for which the Community Power Coalition of New Hampshire serves as agent for purposes of implementing and operating their CPA programs:

These Community Power Aggregations (CPAs) will be launched primarily on an opt-out alternative default service provider basis.

Merrimack County Community Power offers opt-in service to all customers within the county. Merrimack County Community Power will launch service as the default electricity supplier on an opt-out basis for customers in the City of Franklin and the Towns of Bow, Northfield, and Wilmot in accordance with votes of the governing bodies of these municipalities.

Some groups of customers in the CPAs may be offered service only on an opt-in basis, particularly those that cannot be properly served by CPAs until certain data sharing and Puc 2200 rule compliance issues are resolved, including net energy metered customers.
