The Structuring statement should be filed pursuant to Puc 203.04.

AFTER the Prehearing Conference:

Pursuant to Puc 204.07(g) the parties shall file a proposed procedural schedule, with concurrence indicated, including hearing dates, time needed for hearing, prefiled testimony and discovery deadlines.
