PETITION FOR PERMANENT DISCONTINUANCE OF SERVICE

Richard M. Casale, Trustee of the Casale Family 2005 Irrevocable Trust ("the Casale Trust") of 55 Hermit Road, Alton, New Hampshire ("the Property"), pursuant to the attached Letter of Authorization of Charles M. Mobilia Individually and as President of Lakeview Water Company Inc. ("Lakeview"), in accordance with N.H. Admin. Rule Puc 203.05 and Puc 203.06 hereby petitions the New Hampshire Public Utilities Commission ("the Commission") to permanently discontinue the service of Lakeview Water Company, Inc. as the Casale Trust is owner of the Property on which the wells of this previously temporarily discontinued community water system are located. In support of this Petition, the Casale Trust states:

- 1. Lakeview originally filed a petition to dissolve and cease operating as a public utility on June 18, 2006.
- After various hearings, the Commission issued Order No. 25,078 on February 26,
 2010 authorizing Lakeview to temporarily discontinue service ("the Order").
- 3. On information and belief, all improved property owners of lots originally to have been served by Lakeview have their own wells serving their properties.
- 4. Following a thorough review of the Commission's files in the prior Docket No. DW 06 075 as well as files concerning Lakeview at the New Hampshire Department of Environmental Services ("DES") and at the Town of Alton ("the Town"), no complaints have

been generated to the Commission, DES or the Town since the date of the Order concerning the

temporary discontinuance of service.

5. Given the length of time – over 14 years – since the Commission issued the

Order, the Casale Trust seeks to permanently discontinue the service of Lakeview and thereby

remove the cloud on the Casale Trust's title to the Property as a result of having Lakeview's

wells, piping and easements located on the Property.

6. The Letter of Authorization of Charles M. Mobilia Individually and as President

of Lakeview is attached hereto as "Exhibit A".

7. A service list of the current owners of lots who may have been entitled to be

served by Lakeview and/or previously were served by Lakeview is attached hereto as "Exhibit

B". The undersigned is causing a copy of the Petition to be sent to each set of lot owners on

Exhibit B by first class mail giving them notice of this Petition in addition to service on those

required pursuant to N.H. Code Admin. Rule Puc 203.11.

WHEREFORE, the Casale Trust respectfully requests the Commission:

A. Grant this Petition for Permanent Discontinuance of Service; and

B. Grant such other relief as is just and equitable.


