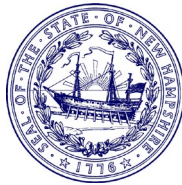

On October 3, 2024, the Commission issued an adjudicative order in the above referenced docket. In the order, the Commission approved the Department of Energy's ("Department") proposed procedural schedule with the exception of the hearing date, instead setting the hearing date for October 29, 2024. The Department's proposed schedule set an original hearing date for October 23rd with exhibits due on October 16, 2024. Also on October 3, 2024, the PUC issued Hearing Guidelines, which requires the parties to file witness lists and exhibits five (5) business days prior to the hearing. Consistent with the Hearing Guidelines the Department will file any exhibits and witness lists by October 22, 2024.
