Based on the attached drawing and relevant distances, Eversource estimates that its Contribution in Aid of Construction to serve this customer would be as follows:

950 feet Total Line Extension Less 300 feet Credit Provided by the Company

650 feet Billable Line Extension X \$31.26 Per Foot Line Extension Rate

Total to be Billed to Customer: \$20,319.00*

* Note, however, this is likely not the total actual cost the Company would incur, as vegetation trimming costs would also be significant.

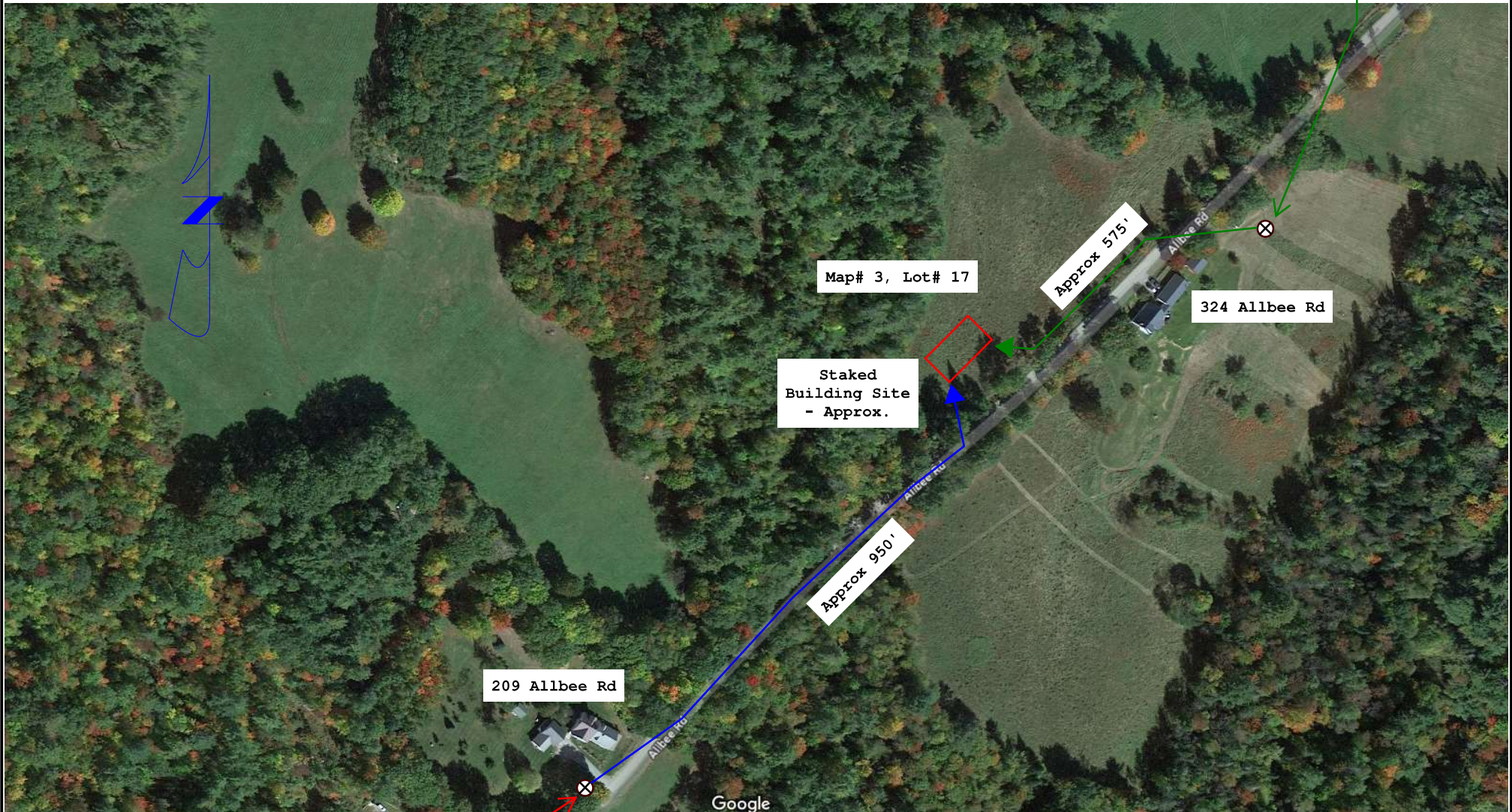
