**LIBERTY UTILITIES (ENERGYNORTH NATURAL GAS) CORP. d/b/a LIBERTY
2025-2026 Local Distribution Adjustment Charge**

Procedural Order Re: Opening New Docket

On August 20, 2024, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty (Liberty) filed a request to approve their 2025–2026 Local Distribution Adjustment Charge (LDAC). On September 3, 2024, Liberty then filed its Winter 2024–2025 and Summer 2025 Cost of Gas (COG) in the same docket. Pursuant to Order No. 26,872 issued on August 14, 2023, in Docket No. DG 23-027, Liberty’s LDAC and COG rate adjustments were separated into two distinct proceedings. For an administrative efficiency and clarity, the Commission finds it appropriate to separate these two matters into two separate dockets. Accordingly, the Commission directs the Clerk’s Office to open a new docket for the COG proceeding and re-file all COG related filings¹ into the new docket.

Any future filings related to Liberty’s COG should be submitted into the new docket.
