Re: Docket No. DG 24-106; Liberty Utilities (EnergyNorth Natural Gas) Corp., d/b/a Liberty Winter 2024-2025 and Summer 2025 Cost of Gas

Dear Chairman Goldner:

On behalf of Liberty Utilities (EnergyNorth Natural Gas) Corp., d/b/a Liberty, I write to notify the Commission of two minor issues with the recently issued Order 27,069 (Oct. 28, 2024) that provisionally approved the winter 2024-2025 cost of gas rates.

First, the table on page three of the order contains a typographical error. The table reads \$0.0688 for G-42 customer where the correct number is \$0.6088 per therm. See Exhibit 11 (the Company's Second Updated filing) at Bates 015.

Second, the sixth ordering clause states:

FURTHER ORDERED, that as discussed in the body of this order, Liberty shall notify its enrolled FPO customers of the approved FPO rate and allow them the opportunity to de-enroll, and shall track costs associated with this notification and de-enrollment.

Order at 5-6. This appears to be an unintentional carryover from Order 26,898, (Oct. 28, 2023) where an *increase* in FPO rates required the Company to provide FPO customers an opportunity to opt out of the program in light of the higher rate. In this docket, the second updated filing resulted in a *lower* FPO rate than contained in the customer notices. Thus, there was no need to provide FPO customers another notice with the opportunity to opt out of the FPO, this issue was not discussed in testimony nor at hearing, and the issue was also not "discussed in the body of this order." Again, it appears to be an inadvertent carryover from last year's order.
