Procedural Order Re: Request to Extend September 4, 2024 Deadline

In Order No. 27,048 (August 21, 2024), the Commission requested the New Hampshire Department of Energy (DOE) to file a procedural schedule, if the parties wanted one, no later than September 4, 2024. *Id.* at 3. On September 3, 2024, pursuant to New Hampshire Code of Administrative Rules, Puc 202.04, the DOE filed a request on behalf of all parties to extend the September 4 deadline to September 16, 2024. The DOE stated that it was unable to coordinate a proposed procedural schedule by September 4 due to vacation and holiday schedules.

The DOE's request for an extension is GRANTED. See N.H. Admin. R., Puc 202.04(c). Any proposed procedural schedule should be filed by September 16, 2024.
