Procedural Order Re: Motions to Consolidate

On June 14, 2024, Unitil Energy Systems, Inc. (UES) filed a motion to consolidate in each of the above-captioned dockets. In its motions, UES requested that both dockets be consolidated, because they concern approval of rates effective August 1, 2024 and involve the same parties and some common issues. No objections to UES's motions to consolidate were filed.


The Commission determines that consolidation of these matters "will promote the orderly and efficient conduct of the proceeding." See N.H. Admin. R., Puc 203.19(a). Accordingly, it GRANTS UES's motions to consolidate pursuant to Puc 203.19. The Commission will issue a supplemental order of notice regarding the additional issues raised by UES's filing in Docket No. DE 24-080.

One day will be allotted for the hearing on both matters on July 30, 2024, starting at 9:00 a.m. The July 30 hearing will also address the substantive issues raised in UES's motion for waiver of the revenue decoupling adjustment cap filed on June 20, 2024 in Docket No. DE 24-077.


