Dear Mr. Kim:

On March 2, 2020, Global Energy, LLC (Global Energy) filed an application to renew its registration as a provider of natural gas aggregation service. On March 6, 2020, Global Energy filed a list of CNGS through which they intend to provide service.

Commission Staff filed a memorandum on March 11, 2020, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 3000. Staff recommended that Global Energy's registration application be approved for a five-year term, beginning on March 28, 2020.

The Commission has approved Staff's recommendation. Accordingly, Global Energy's application for registration is approved, effective as of March 28, 2020. The renewed registration is for a term of five years and expires at the close of business on March 28, 2025. Pursuant to Puc 3003.05(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before January 27, 2025.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:
